RESOLUTION WAIVING REQUIREMENTS FOR THE ROCKVILLE CENTRE FIRE DEPARTMENT TO FILE VARIOUS INFORMATION AND REPORTS WITH THE BOARD OF TRUSTEES AS A PRECONDITION TO NEGOTIATING CONTRACTS WITH THE VILLAGE FOR FIRE PROTECTION AND/OR EMERGENCY AMBULANCE SERVICE

Whereas, pursuant to Village Law §4-412(3)(9)(a-1) ("Chapter 294"), as enacted by L. 2017, c. 294 and effective January 1, 2018, before an incorporated village may consider a contract with an incorporated fire company for a fire protection and/or emergency ambulance service to take effect on or after March 1, 2018, the fire company must file with the Board of Trustees:

a statement itemizing the estimated costs of the incorporated fire company attributable to the provision of services under the prospective contract. The estimated costs attributable to the provision of services under the prospective contract itemized in the statement shall include, at a minimum, those, if any, for: supplies; materials; operation, maintenance and repair of equipment and apparatus; insurance; training; protective clothing, gear and other personnel costs; building rental, maintenance and operation; and a specified proportionate share of capital costs,

and, if otherwise required to be filed, copies of:

- (A) the fire company's most recent annual report of directors pursuant to section five hundred nineteen of the not-for-profit corporation law;
- (B) the fire company's most recent verified certificate pursuant to subdivision (f) of section fourteen hundred two of the not-for-profit corporation law;
- (C) the fire company's most recent internal revenue service form 990; and
- (D) the fire company's most recent annual report pursuant to section thirty-a of the general municipal law, and

Whereas, Chapter 294 further provides that the Board of Trustees may waive that filing requirement upon good cause shown, and

Whereas, in the Village of Rockville Centre, the Board of Trustees is the Board of Fire Commissioners for the Rockville Centre Fire Department, and is fully familiar with the management and operations of the Fire Department, and

Whereas, the Board of Trustees hereby finds and determines compliance with the requirements of the aforesaid statute would be burdensome upon the Fire Department, and would not provide the Board of Trustees with information not already available to the Board of Trustees,

Now, therefore, be it

RESOLVED, that pursuant to the authority granted to it in Chapter 294, the Board of Trustees hereby finds and determines that good cause exists to waive the aforesaid filing requirements with respect to contracts between the Village and the Rockville Centre Fire Department for fire protection and/or emergency ambulance service, and it is further

RESOLVED, that the Board of Trustees hereby waives compliance with any such filing requirements as enumerated in Chapter 294 with respect to contracts between the Village and the Rockville Centre Fire Department for fire protection and/or emergency ambulance service, such waiver to be effective immediately and to remain in effect until rescinded by resolution of the Board of Trustees.
