On motion of Trustee Oppenheimer, duly seconded by Trustee Baxley and carried by a vote of four to none the Board authorized the Mayor or his designee to execute an amendment to the PY42 CDBG contract with Nassau County to expand the Downtown Revitalization project to include South Village Avenue between Lincoln and Merrick and North Village Avenue between Sunrise and Front Street in the form approved by the Village Attorney.

On motion of Trustee Oppenheimer, duly seconded by Trustee Sepe and carried by a vote of four to none, the Board as Lead Agency, adopted the following resolution classifying the infrastructure improvements on South Village Avenue from Riverside Drive to Merrick Road as a Type II action under SEQRA.

On motion of Trustee Oppenheimer, duly seconded by Trustee Sepe and carried by a vote of four to none, the Board awarded the contract to Harder Tree Service Inc., as the lowest responsible bidder substantially meeting all required specifications, for 2018-2019 for a total expenditure not to exceed \$95,580.00-.

On motion of Trustee Oppenheimer, duly seconded by Trustee Sepe and carried by a vote of four to none the Board adopted the following resolution rescinding a prior award, and making a new award, for Bid No. 1812DPW1(892).

**RESOLUTION RESCINDING BID AWARD AND AWARDED BID TO LOWEST RESPONSIBLE BIDDER MEETING ALL SPECIFICATIONS**

Whereas, the Village previously has solicited bids for Grounds Maintenance (Bid #1812DPW1(892)); and

Whereas, bid addenda, including Addendum #3, were sent to prospective bidders prior to the bid submission date; and

Whereas, Addendum #3 was issued on January 3, 2018, and provided a form for "Schedule of Prices" to replace the pricing schedule in the original bid documents, and which form contained an itemized list of costs, in place of a lump sum format; and

Whereas, three (3) bid proposals were timely submitted, including bid proposals from Del Graz Enterprises, Inc. ("Del Graz"), d/b/a R&R Landscaping, KIG Landscapes, Inc. ("KIG"), and Harder Services, Inc.; and

Whereas, the Del Graz bid included both the Schedule of Prices required by Addendum #3 and the pricing schedule (that was to be replaced by the Schedule of Prices); and

Whereas, Addendum #3 in the Del Graz proposal provided a cost of \$121,950 for lawn maintenance, plus \$34,900 for fall cleanup, and \$4,764 for tree beds, horticultural oil and lime ("Additional Work"), for a total proposed bid of \$161,614; and

Whereas, the Board of Trustees previously determined to award the bid to Del Graz, excluding the fall cleanup; and

Whereas, upon such exclusion, the Del Graz bid (for year one) was \$126,714.00; and

Whereas, on February 5, 2018, the Board of Trustees adopted a resolution accepting the proposal from Del Graz for 2018 at a cost not to exceed \$126,714, and \$129,248.28 for Option Year 1 and \$131,833.25 for Option Year 2; and

Whereas, on February 5, 2018, the Village issued a purchase order to Del Graz to commence work; and

Whereas, upon receipt of the purchase order, Del Graz informed the Village that the Del Graz proposal of \$121,950 included only cutting and not full lawn maintenance, and that the cost proposal for the full lawn maintenance, including cutting, should be considered to be \$152,800; and

Whereas, Del Graz had submitted a sheet in its bid identifying the cost proposal of \$152,800, but did so on the pricing schedule form that was replaced pursuant to Addendum #3; and

Whereas, Del Graz also submitted the correct "Schedule of Prices" form, as provided in Addendum #3, and the cost proposed for full lawn maintenance in the proper form was \$121,950; and

Whereas, the Village had accepted the Del Graz proposal based on the cost identified in the proper form – the "Schedule of Prices" – which provided a proposal of \$121,950 for lawn maintenance; and

Whereas, Del Graz now has stated that it cannot perform the lawn maintenance work for \$121,950, and instead seeks to perform the lawn maintenance work for \$152,800, and combined with the Additional Work results in a total of \$157,564; and

Whereas, the Village is strictly prohibited under the General Municipal Law from authorizing an amendment or reformation of a bid to rectify an error or mistake; and

Whereas, KIG Landscapes proposal for all work, excluding fall cleanup, is \$148,140; and

Whereas, the Village has not concluded a contract with Del Graz and Del Graz has not performed any work as provided in the aforesaid purchase order; and

Whereas, in light of the foregoing circumstances, the Board has determined that it is in the best interests of the Village to rescind the award to, and reject the bid of, Del Graz, on the grounds that Del Graz refuses to perform the work for the bid and award amount of \$126,714.00 and that the alternative amount proposed by Del Graz (\$157,664) does not comply with Addendum #3 or the bid requirements and would render Del Graz to be the second lowest bidder; and

Whereas, the bid from KIG Landscapes, Inc. is the lowest remaining bid, and the Purchasing Department has recommended that the Village award the contract to KIG Landscapes, Inc., as the lowest responsible bidder for a sum not to exceed \$156,840.00, as provided in the KIG bid proposal, which sum excludes the fall cleanup;

NOW, therefore, it is

RESOLVED, that the Board of Trustees of the Village of Rockville Centre hereby rescinds its February 5, 2018 resolution authorizing acceptance of the proposal from Del Graz for Grounds Maintenance (Bid #1812DPW1(892)), and rescinds the aforesaid purchase order issued to Del Graz; and it is further

RESOLVED, that the Board of Trustees of the Village of Rockville Centre hereby determines that KIG Landscapes, Inc. has submitted the lowest bid conforming to statutory and bid requirements, and awards to KIG Landscapes, Inc. the contract to perform the work identified in the 2018 Grounds Maintenance bid for a cost not to exceed not to exceed \$156,840, and \$161,545.20 for Option Year One and \$166,391.56 for Option Year Two.
