**Local Law No. 11 of the year 2011**

**A local law to amend the Code of the Village of Rockville Centre, in relation to issuance**

Section one. Notwithstanding the provisions of Village Code Chapter 222, and Village Code 300-4, any tow license heretofore granted by the Village for towing at police request which is valid and in good standing on June 30, 2011, and which otherwise would expire on such date, shall be extended to and including September 30, 2011 upon payment to the Village of thirty-three and one-third (33 1/3 %) per cent of the annual fee otherwise provided by law for each such license.

Section two. Commencing with the effective date of this law, and continuing to and including September 30, 2011, no new license shall be issued by the Village for

towing at police request. Notwithstanding the foregoing, on or after September 1, 2011 the Village may accept applications for such towing licenses to be effective on and after October 1, 2011 as may then be provided or authorized by law.

Section three. Section 300-5.1(B) of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

“B. The Board of Trustees may determine by resolution, in its sole discretion, to limit the number of towing licenses or issue such licenses on other or different terms and conditions as may be determined by the Board, including limiting the number of such licenses and issuing licenses by random selection among qualified applicants therefore, or by public auction, bids or proposals, provided however that no such method shall terminate any license prior to the expiration of the term thereof. The Board of Trustees may also determine by resolution, in its sole discretion, that no new or renewed towing license shall be issued by the Village for towing at police request pursuant to this Chapter, and that the Village shall instead enter into one or more contracts or concessions for towing services to be provided at police request, upon terms and conditions determined by the Board.”

Section three. This local law shall take effect July 1, 2011.
