A local law amending the Code of the Village of Rockville Centre, in relation to the location of sprinkler pipes and sprinkler heads between curbs and property lines.

Section one. Section 287-15 of the Code of the Village of Rockville Centre is hereby amended, to read as follows:

“§ 287-15. Prohibition. Except as provided in Chapter 118, Building Drains, no person shall install, construct, place or maintain, or permit to be installed, constructed, placed or maintained, in the area between the curb and property line of premises owned or occupied by him, adjoining any street, parking field or parking field walk, any structure, masonry, stones, sprinkler pipes, sprinkler heads, garbage receptacles or any

similar devices or fixtures. Notwithstanding the foregoing, sprinkler pipes and sprinkler heads may be located in such area with the written permission of the Superintendent of Public Works, provided that any such permission shall be granted only on condition that the Village shall not be responsible for any damage to such sprinkler pipes and sprinkler heads, or costs to replace or repair the same, or any other consequential damages resulting from any Village maintenance or repair activity conducted in the area of such sprinkler pipes or sprinkler heads. “

Section two. If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Board of Trustees of the Village of Rockville Centre hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

Section three. Effective Date. This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with the Municipal Home Rule Law
