Sandel Center Re-accredited

Rockville Centre's Sandel Senior Center, the first senior facility on Long Island accredited by the National Institute of Senior Centers, a unit of the National Council on Aging, has had its accreditation renewed for another five years. The Center was initially accredited in 2004.

"We're absolutely thrilled by this validation of our programs," said Dr. Cyd Charrow, D.S.W., the Village's Director of Senior Services. "Thanks go to the Village and the community for supporting our department and to the Blue Ribbon Committee that directed the re-accreditation process," she said.

During that process, the committee collected and studied demographic and attitudinal information to project the needs of both the Center and the Department of Senior Services, reviewed their missions, policies, programs and operations, and set goals for the future

Mayor Mary Bossart, a member of the Blue Ribbon Committee, said, "Village residents and volunteers who contribute directly to the Center or to the Friends of Senior Services (FOSSI) should be

Facing Tough Choices on the Budget

The Holidays are upon us and we're all busy decorating and celebrating. Family and friends will join together to renew and recommit. But December also marks the start of budget preparation for the upcoming fiscal year, the one that will cover the Village's operations for the period from June 1, 2010 through May 31, 2011. And I'd like to begin the discussion of some of the

critical issues and choices that will impact the Village's financial future.

There are some increases in Village expenses that lie ahead that can't be avoided:

- ♦ Contributions to the New York State Pension Fund for our employees will increase by an estimated \$700,000 to \$2.23 million, an amount that is set by the State and over which we have no control. This reflects a nearly 50 percent increase over this year's budget.
- ♦ Our bond debt service will increase by almost another \$600,000. This will cover items that the Board has already approved, including the resurfacing of 1.4 miles of Village streets, repairs to our parks and recreation facilities, repairs to the building at 110 Maple (you've probably noticed the scaffolding), the replacement of three pieces of equipment used in the public works area, and the computer used to track the Village's finances all of which are nearly 20 years old.
- ♦ We're also faced with replenishing the fund that we use to make contractual lump-sum payments to our police officers when they retire.

Taken together, these expenditures total nearly \$1.8 million in spending beyond this year's budget. Our comptroller tells us that each \$240,000 in increased spending adds 1 percent to our property taxes. If we are unable to identify significant savings or increases in other revenues, we are faced with a $7\frac{1}{2}$

percent tax hike for these items alone.

And these numbers don't factor in that the collective bargaining agreement with our police officers expires this December 31 and with the rest of our work force on May 31. Obviously, these negotiations with the unions will be crucial as we go forward.

Although a smaller figure, the contract between the

Village and St. Agnes for the use of the church's parking lot also expires in the coming fiscal year. Under the current contract, we are paying nearly \$63,000 for the weekday use by commuters of those 100 spaces.

I know that all of the Village managers and the Board will continue to work hard to wring whatever savings we can out of Village operations. Our current budget already reflects significant savings because of our new contract for the disposal of our solid waste. We also cut 10 positions from our work-force in the current year. But at some point, and we may be at that point in some of our departments, there's little more that can be done without the wholesale dismantling of Village operations.

These kinds of numbers are hardly filled with holiday cheer. But it's the hard reality we're facing and I think it's critical that we all be as informed as possible about what lies ahead.

Leaf Collections End December 17

Rockville Centre's curbside leaf collections will end Friday, December 17.

Leaves no longer have to be placed in special leaf bags. They may now be collected into ordinary plastics bags and put at the curb on pick-up days for recycling by the Village's new sanitation contractor.

Bagged leaves will be collected from the curbstrip on the following schedule:

Mondays – South of Sunrise Highway

Tuesdays – North of Sunrise Highway and east of Long Beach Road

Wednesdays – North of Sunrise Highway, west of Long Beach Road, east of Hempstead Avenue

Thursdays – North of Sunrise Highway and west of Hempstead Avenue

Locks and Lights During Burglary Season

Although Rockville Centre is very well protected and the crime rate is very low, the holiday season is, unfortunately, a prime time for home burglaries. Criminals know that homes are often filled with gift purchases this time of year and that people are often away from home attending events and parties.

RVC Police Commissioner Jack McKeon said, "Burglaries are crimes of opportunity. Burglars go for the easy targets first, so don't leave inviting items in plain sight behind unlocked doors and windows. Lock your cars, lock your garage, lock your house."

To reduce your chances of becoming the victim of a burglary, the police recommend the following:

1. If you have an alarm system, keep it armed even when you are at home. (Village permits are required for all alarms.)

- 2. Keep doors, windows, and all entry points closed and locked. If you need to keep windows open, ask your alarm company to provide specially- wired screens. Look outside before opening your door.
- 3. Keep lights on outside your home at night. Be sure to try to illuminate trees and shrubs along the house, where people might hide. Keep ladders or other items that could help an intruder enter a ground floor window in a locked garage or shed.
- 4. Keep an eye on your neighborhood and report anything or anyone that is suspicious to the police by using 911 or 766-1500. It is always better to be safe than sorry.

(Remember, calls from cell phones go first to Nassau County; calls from land lines come right to the Rockville Centre Police.)
