Village Approves Lowest Real Estate Tax Rate Increase in 24 Years

For the fifth consecutive year, the Rockville Centre Board of Trustees passed a budget that stays within the tax cap while maintaining Village services at present levels. The budget of \$44,731,111 includes a tax levy growth of 1.66% and complies with the limit established by the New York State Real Estate Property Tax Cap program. The Real Estate Tax Rate increase of 1.72%, approximately \$65.06 for the average household, is the smallest increase in 24 years.

Like every municipality, increasing costs including those mandated by other levels of government, have challenged the Village of Rockville Centre. However, the Village of Rockville Centre has risen to the challenge and refuses to pass all the increased costs along to homeowners through higher real estate taxes. Instead the Village has been

creative in the way they operate and has implemented prudent fiscal policies. These policies have been recognized by Standard & Poor's Rating of AAA, the highest possible rating, and Moody's rating of AA2, one of its highest ratings.

"I believe the 2018 budget balances the need to hold down taxes and maintain the services that residents have come to expect and enjoy," commented Mayor Francis X. Murray. "At the same time, we are staying under the tax cap for the fifth consecutive year. In addition, this budget should preserve the impressive financial stability and strength of our Village."

Over the last few years under the Mayor's leadership, over \$15 million dollars in federal, state, local grants, and gifts have been secured to make improvements within the Village. Much of the money has

been used to improve roadways, parks and services for seniors. In addition, grants have been obtained to help our Police and Fire Departments utilize state-of-the-art equipment to keep residents safe.

"The spending plan we are putting forth is the product of a great deal of work by the Village Administrator, Comptroller, and our department heads to hold down costs wherever possible," continued Mayor Murray. "We will continue to look for ways to reduce costs and bring in additional revenue to the Village, including being aggressive in pursuing grant money, private/public partnerships, and gifts to make improvements at little expense to our residents."

Organizations and groups from across Nassau County and New York City marched on behalf of three worthy charities including the Backyard Players and Friends, Breathe Believe, and

Pieta House. Since the parade's inception in 1997, over \$1 million has been distributed to 58 individual charities. Rockville Centre's St. Patrick's Parade is "The Parade that Cares and Shares"®. Grand Marshal Patricia Ann Norris-McDonald, a Rockville Centre native and Village of Malverne Mayor, led the parade this year.



RVC Awarded Certificate of Achievement

For the 21st consecutive fiscal year, the Village of Rockville Centre has been awarded the prestigious "Certificate of Achievement for Excellence in Financial Reporting" by the Government Finance Officer Association of the United States and Canada (GFOA). The recognition is for the Village's comprehensive annual fiscal report (CAFR).

The Certificate of Achievement is the highest form of recognition in the area of governmental accounting and financial reporting, and its attainment represents a significant accomplishment by a government and its management. When the COA is

awarded, an Award of Financial Reporting Achievement is also presented to the individual designated by the government as primarily responsible for its having earned the award. This has been presented to Village Administrator Kathleen Murray, who worked closely with the Village Comptroller's office and auditors to assure that the Village's financial reporting met very high standards.

"I am thankful to the staff of our Comptroller's Office, led by George Scheu, for their efforts to be up-front and accurate in the way they report the Village's financial information," commented Mayor Francis X.

Murray. "This award reflects the value this Village's government puts on transparency for the benefit of our taxpayers."

The CAFR is judged by an impartial panel to meet the high standards of the program, which includes demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story and motivate potential users and user groups to read the CAFR. The GFOA is a nonprofit professional association serving approximately 17,500 government finance professionals with offices in Chicago and Washington, D.C.

Village Awarded \$1 Million for Microgrid Energy System

The Village of Rockville Centre was awarded \$1 million in funding as part of the second stage of the NY Prize Community Microgrid competition. Microgrids provide critical power backup for homes, businesses, hospitals and other vital facilities during extreme weather events and emergencies, while supporting development of on-site cutting edge renewable energy technologies.

“The Village of Rockville Centre has taken lessons learned from Superstorm Sandy and is working to ensure that facilities providing vital services have power to address residents’ health and safety needs,” commented Mayor Francis X. Murray. “This award brings us one step closer to our goal.”

As part of the competition, the Village of Rockville Centre will receive \$1 million through the New York State Energy Research and Development Authority, which administers the NY Prize, to conduct engineering, develop specifications, obtain bids and prepare business plans for a microgrid to bring local clean energy generation and backup power to their communities. Rockville Centre

was awarded \$100,000 for the first stage of the competition, for feasibility studies, in July of 2015. Rockville Centre plans to submit an application for Stage three of the competition and will have access to financing for microgrid construction through NY Green Bank, in addition to the \$20 million available through NY Prize. Winners are expected to be announced by the end of 2018.

“I’m delighted that our Village and our proposal were selected to receive funding for this critical reliability project,” stated Superintendent of Electric Phil Andreas. “One of the great attractions to living in our community is the reliability and low cost of energy. This grant will help us improve our electric infrastructure and allow us to control our own destiny when it comes to clean resources to generate power.”

The Rockville Centre proposed microgrid would include up to 1-2 MW of solar power, 6 to 12 MW of dual-fuel or gas-fired generation, as well as potential inclusion of energy storage and demand-side management. The planned microgrid would serve residents

and 34 critical facilities including South Nassau Communities Hospital, police and fire services, Village Hall, an assisted living center, and vital retail businesses.

“I would like to thank Governor Cuomo and NYSERDA for the NY Prize Community microgrid and investing in a more sustainable

future,” continued Mayor Murray. “I would also like to thank Senator Todd Kaminsky and Assemblyman Brian Curran for their continued support on our journey with this incredible opportunity to enhance our generating facility in Rockville Centre.”

RVC Police Installs Drug Drop-Off Box



The Rockville Centre Police Department, through a partnership with CVS Pharmacy, installed a new disposal box at police headquarters for residents to dispose expired or unused medications in a safe and easy manner. The new drop-off box was installed next to the front door in early April.

Only non-controlled drugs and substances will be accepted, such as prescription patches, ointments, over-the-counter medications, vitamins, samples and pet medicines. Items that will not be accepted include hydrogen

peroxide, thermometers, needles, aerosol cans, medications from businesses or clinics, lotions and liquids.

The RVC PD recently hosted its second “Drug Take-Back Day” on April 29th. The biannual program started about 10 years ago in conjunction with the United States Drug Enforcement Administration, which disposes of hundreds of medications after each session. The program will provide another opportunity for citizens to properly dispose of their drugs in an environmentally safe manner.

PROTECT YOUR FLOWERING PEAR TREE

The Village would like to inform all residents that we are facing a problem with all the flowering pear trees which have been planted throughout our Village over the years.

In the past year, we have noticed that an increasingly large number of these trees have become diseased. There is more than one disease affecting these trees. Symptoms may include, but are not limited to, less flowers, less leaves, undersized leaves, leaves that may be discolored or blotchy, leaves falling prematurely and a general decline in health. Unfortunately, when a large number of trees of the same variety are planted in one area, it allows the diseases to spread very quickly throughout the area.

We recommend that residents contact their licensed pesticide applicator so that the disease can be identified and proper controls can be administered. This is a serious issue that if unaddressed, we stand to lose all the flowering pear trees which have been planted throughout our community.

WHY DOES THE VILLAGE OFFER YOUNG TREES AND NOT LARGER ONES?

The Village offers trees that are 2 to 2 1/2" in diameter for the following reasons: price, survivability, root ball size and growth rate. Price: Trees that are this size are economical. As trees get larger, their price goes up disproportionately to their size. Survivability: Trees of this size transplant very well and have a very high rate of survivability. Root Ball Size: Trees of this size have root balls which fit comfortably between the curb and sidewalk. Growth rate: Smaller transplant trees recover faster from transplant shock and begin growing faster than larger trees. Please keep the mature tree in mind when spacing plantings.

CAN I ORDER A TREE FOR LOCATIONS OTHER THAN MY CURB?

While the Village can only plant trees on the strip between the sidewalk and the curb, you are welcome to purchase trees, which will be delivered directly to you, to be planted elsewhere on your property. The price for the tree only is \$250 and the price for the tree and planting is \$350.

WHEN CAN I ORDER AND WHEN WILL MY TREE BE PLANTED/DELIVERED?

You can order trees now through September 15, 2017. Trees will be planted/delivered late November/early December.

IS MY TREE GUARANTEED?

Trees are guaranteed for one year. If the tree you purchased dies within a year, it will be replaced with a new tree for free. After the first year, homeowner is responsible for all maintenance of the trees.

2017 TREES



Pin Oak:
(*Quercus Palustris*)

This hardy shade deciduous tree has a spreading canopy that can block sunlight. It is a fast growing tree and grows to a height of 60-70' with a spread of 25-40' at maturity. It is a full sun tree so it needs at least 6 hours of direct sunlight a day. It tolerates wet conditions well, as well as heat, pollution and compact soil. It offers dense shade and features glossy, dark green leaves that provide great fall color when the leaves turn shades of scarlet and beige. This tree requires acid soils, is intolerant to alkaline soils, Intolerant to drought conditions and tolerant to poor draining conditions. This tree does yield yellow-green catkins in the spring as well as acorns. Spacing: 20 Feet



Thundercloud Plum:
(*Prunus Cerasifera*)

This is a hardy flowering deciduous tree that is fast growing. The tree grows to a height of 15-25' with a spread of 15-20' at maturity. It is a full sun tree so it needs at least 6 hours of direct sunlight a day. It produces showy, fragrant pink and white small flowers in the spring and has coppery, purple leaves that hold their color into fall. This tree also produces small red edible fruit. This low maintenance tree prefers slightly acidic, moist, well-drained soil. This tree attracts butterflies and is bird friendly. Spacing: 10-15 Feet



Japanese Lilac:
(*Syringa Reticulata*)

This is a hardy flowering deciduous tree that is moderate growing. It grows to a height of 20-25' with a spread of 20-25' at maturity. It is a full sun tree so it needs at least 6 hours of direct sunlight a day. Its leaves are green and what makes this tree different from other flowering trees is that its fragrant, white flowers bloom in early summer and the leaves and flowers are on the tree at the same time. This tree is tolerant of acidic and alkaline soils. It prefers moist, well-drained soil. Spacing: 10-15 Feet



Kwanzan Oriental Cherry:
(*Prunus Serrulata*)

This is a hardy, flowering, ornamental deciduous tree. It is a moderate growing tree and grows to a height of 30-40' and a spread of 20-40' at maturity. It is a full sun tree so it needs at least 6 hours of direct sunlight a day. It produces an amazing profusion of deep pink double flowers from April to early May and its leaves are reddish/copper as they emerge, then dark green by summer and yellow, orange or bronze in the fall. It grows well in all soils and is somewhat drought tolerant. It does not produce fruit and has a limited life span of 15-25 years. Spacing: 30 Feet



Little Leaf Linden:
(*Tilia Cordata*)

This hardy shade, flowering deciduous tree has a spreading canopy that can block sunlight. It is a moderate growing tree and grows to a height of 50-60' and a spread of 40' at maturity. It is a full/partial sun tree so it needs at least 4 hours of direct sunlight a day. It offers dense shade and features light green leaves that turn to glossy dark green then turns to yellow. This tree blooms in summer and produces clusters of yellowish flowers that hang down on a long stalk attached to a leaf-like wing. This tree is tolerant of acidic and alkaline soils and is intolerant to drought and poor draining conditions. Spacing: 20 Feet



Male Ginkgo Biloba:

This hardy, ornamental shade deciduous tree has a spreading canopy that can block sunlight. It is a moderate growing tree and grows to a height of 25-50' and a spread of 25-35' at maturity. It is a full/partial sun tree so it needs at least 4 hours of direct sunlight a day. Its fan-shaped leaves are bright green until turning yellow in the fall. It grows well in all soils and tolerates moderate drought conditions and wetness well. The male tree does not bear fruit. Spacing: 15 Feet
